## **Internal Complaints Committee**

### **Objectives of ICC:**

The objectives of the Internal Complaint Committee to Prevent Sexual Harassment of Women at the Workplace are as follows:

- To develop a policy against sexual harassment in the college premises.
- To take necessary steps to implement the policy.
- To develop proper and easy mechanism to report the complaints and timely disbursal of the matter.
- To create a safe physical and social environment in the college for women.
- To device a mechanism to prevent any kind of gender based violence in the college.

### **Background & Rationale:**

The constitution of India ensures the right of a woman to gender equality under Article 14, also Article 21 provide right to life and live with dignity. These two fundamental rights enshrined in our constitution forms the basis of any act against sexual harassment.

The <u>Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal)</u> (PoSH) Act, 2013 is a legislation enacted by the Government of India in 2013 to address the issue of sexual harassment faced by women in the workplace. The Act aims to create a safe and conducive work environment for women and provide protection against sexual harassment. The PoSH Act defines sexual harassment to include unwelcome acts such as physical contact and sexual advances, a demand or request for sexual favours, making sexually colored remarks, showing pornography, and any other unwelcome physical, verbal, or non-verbal conduct of a sexual nature.

The Internal Complaints Committee (ICC) of Government General Degree College, Muragachha has been set up according to the guidelines of the PoSH Act, 2013. However, ICC was set up not only to deal with complaints of sexual harassment of women in the workplace but also to focus on creating awareness, counseling and educating about gender issues.

### **Jurisdiction:**

The policy and the rules & regulations would apply to all students, faculty, and nonteaching staffs on active roles and also apply to service providers and outsiders who may be within the territory of the Government General Degree College, Nakshipara.
