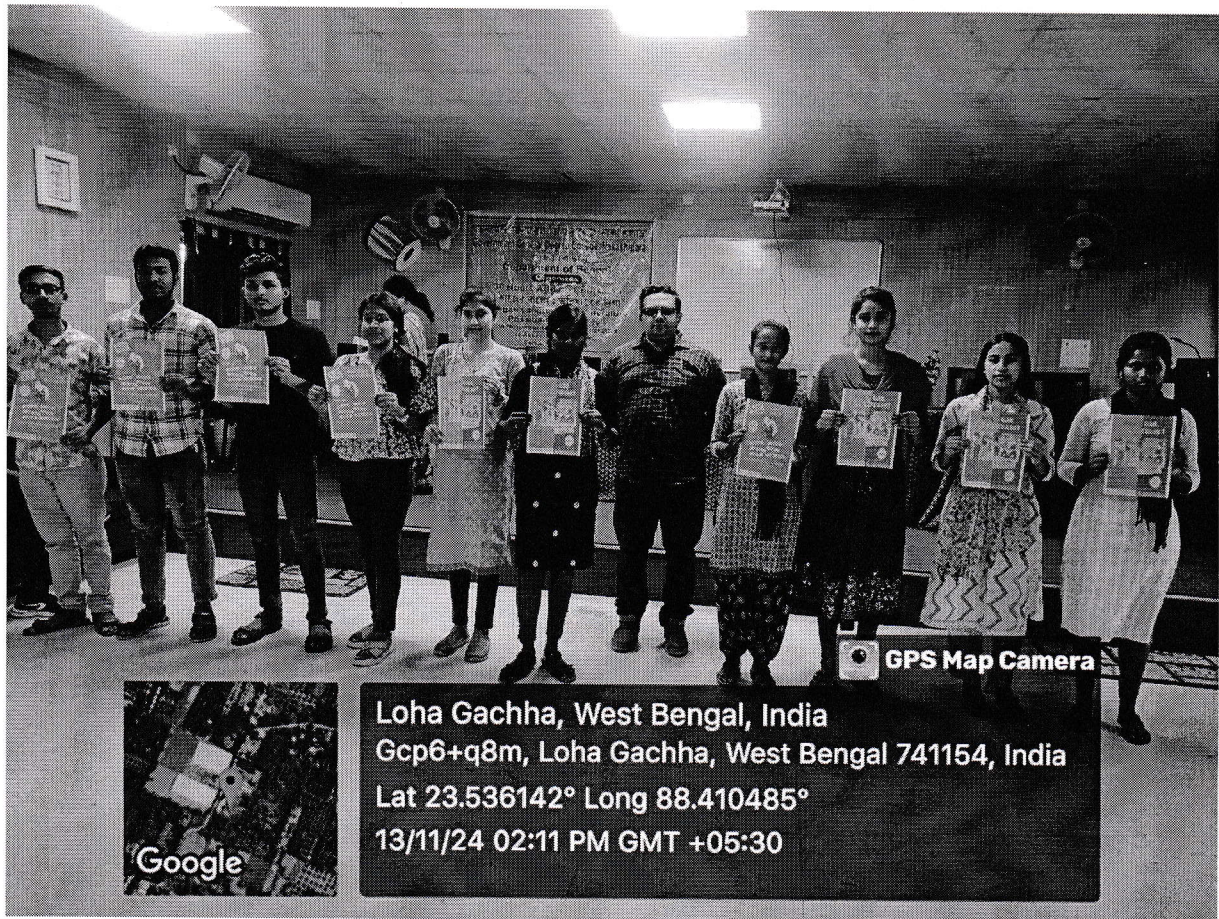

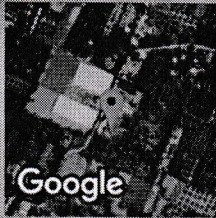

1. Mental/Physical / Sexual abuse
2. Verbal abuse
3. Indecent behaviour
4. Criminal intimidation/Wrongful restraint
5. Undermining human dignity
6. Financial exploitation / Extortion
7. Use of force

##### A student indulging in ragging can be:

1. Expelled from the institution
2. Banned from the mess/hostel
3. His/her scholarship can be withdrawn
4. Debarred from examinations
5. Denied admission to any institution
6. Prosecuted for criminal action
7. Institutions have been asked to file FIR with local police against those who RAG/ABET ragging


