#### 2. Submission of bids:

Both Technical bid and Financial Bid are to be submitted concurrently duly digitally signed by the Company personnel who is in the pay roll of the Company (having Authorization from the Company management) in the website <u>http://wbtenders.gov.in</u>. All papers must be submitted in English language.

#### 3. The eligibility criteria are given below:

1. The accepting authority reserves the right to reject any or all the quotations without assigning any reason thereof.

2. The participating bidders are requested to quote their rate both in figures and in words.

3. Conditional/incomplete rates will not be accepted under any circumstances.

4. The articles should be delivered and installed to the ultimate destination at their own cost. No extra charge will be borne by the tender inviting authority.

5. Any item found to be damaged/defective should be replaced by the supplier/agency and for such

replacement if there be any no charge will be borne by the tender inviting authority.

6. Fitness certificate/safety certificate must be produced from the competent authority.

7. Quotation documents are non-returnable.

8. GST-TDS will be deducted as per Government rules.

9. As per Government rules, income tax shall be deducted at source for payments against bills submitted.

10. The tender should be submitted in the pro forma enclosed herewith.

11. The violation of any of the conditions will entitle cancellation of the order.

12. Scan copy of form of Income Tax return for the last three financial year, GST Registration certificate,

PAN No., Current Trade license, Current license of Home & Hill affairs Department, Govt. of West Bengal, P.Tax other related licenses and registration certificates, if any, and also credentials.
